Consultation will consist of face-to-face meetings either individually or in group consultation. We may conduct remote/distance consultation via technology when deemed necessary by Vickie George of ACC with the understanding that all platforms meet security/HIPAA standards and a BAA is in place. Vickie George will further assess it as being appropriate for mental health services and ACC's own Consent for Telemental Health Supervision will need to be in place before any Telemental Health Supervision takes place. The consultation consists of case discussion and review, reading appropriate materials, and clinical observation (live) of the Consultee by Vickie George. Consultee will see clients in his/her professional office.

It will be the Consultee's responsibility to maintain a case log during the course of consultation. The log will contain the date and type of case. Vickie George will keep a similar log. The Consultee is expected to abide by the rules and regulations of the state in which they reside **as well as** the rules and regulations of the state of Georgia in which Vickie George resides. Vickie George will help with understanding and following the rules and regulations of the state of

Georgia if the Consultee lives out of state. Both Vickie George and the Consultee will abide by the ethical codes of BOTH of their respective professions. Vickie George will seek for the Consultee to operate out of a sense of Aspiring Ethics of the profession. Failure to do so will result in termination of this Consultation Contract with Vickie George of ACC and can result in the denial of any certifications achieved by ABCST.
